- be licensed in the name of the legal entity as identified under applicant details.
- the organisation must be predominantly/solely funded through donations and/ or government grants.

Where the organisation has not previously applied for or been granted a concession, the following documentation must be supplied:

- a copy of the organisation's constitution;
- documentation from the Australian Charities and Not-for profits Commission (ACNC) providing evidence that the organisation is a 'public benevolent institution', or a 'charitable institution'; and
- evidence that the organisation is an incorporated body (Certificate of Incorporation) or a legal entity.

Under the provisions of the Road Traffic (Vehicles) Act 2012, where a licence concession is granted and the vehicle is used for purposes other than those for which the concession was granted, the vehicle is deemed unlicensed.
