



## **DoT Approved Driver Protection Screens for Taxis - Appendix A**

Please find below the DoT approved driver protection screens for taxis, and the vehicles which they can be fitted in.

Note that driver protection screens must **ALWAYS**:

- be installed according to the manufacturers instructions; and
- be in a fit and serviceable condition.

### **Martin BodyGuard II**

Approved for installation in Ford Falcon BA to BF vehicles and the corresponding Fairmont, Fairmont Ghia, Fairlane and LTD versions of those Ford vehicles. This approval is inclusive of vehicles fitted with side airbags (fitted within the driver's seat) but excludes those vehicles fitted with side curtain style airbags (fitted above the driver's side window/s).

### **TransitShield Model TSAVIC08**

Approved for installation in Ford Falcon BA to BF vehicles and the corresponding Fairmont, Fairmont Ghia, Fairlane and LTD versions of those Ford vehicles. This approval is inclusive of vehicles fitted with side airbags (fitted within the driver's seat) but excludes those vehicles fitted with side curtain style airbags (fitted above the driver's side window/s).

### **Khoto 1001**

Approved for installation in Ford Falcon BA to BF vehicles and the corresponding Fairmont, Fairmont Ghia, Fairlane and LTD versions of those Ford vehicles. This approval is inclusive of vehicles fitted with side airbags (fitted within the driver's seat) but excludes those vehicles fitted with side curtain style airbags (fitted above the driver's side window/s).

### **The Martin Bodyguard MBGTA 4000**

Approved for installation in Toyota Avalon vehicles model years 2000 to 2006 licensed as taxi-cabs in Victoria. This approval is inclusive of vehicles fitted with dual front airbags but excludes those vehicles fitted with side curtain style airbags (fitted above the driver's side window/s) and side airbags deployed from the B Pillar or driver's seat. ### **The Khoto2001A**

Approved for installation in Toyota Avalon vehicles model years 2000 to 2006 licensed as taxi-cabs in Victoria. This approval is inclusive of vehicles fitted with dual front airbags but excludes those vehicles fitted with side curtain style airbags (fitted above the driver's side window/s) and side airbags deployed from the B Pillar or driver's seat. ### **The TransitShield Model TSATOY-201**

Approved for installation in Toyota Avalon vehicles model years 2000 to 2006 licensed as taxi-cabs in Victoria. This approval is inclusive of vehicles fitted with dual front airbags but excludes those vehicles fitted with side curtain style airbags (fitted above the driver's side window/s) and side airbags deployed from the B Pillar or driver's seat. ### **The Martin Bodyguard MBGTH5000**

Only approved for installation in 2005 and later model (i.e. current shape) Toyota HiAce Vans that have an Access Seating Australia Pty Ltd (Model number A.S.A. - 04) rear facing seat as the second row of seats. Operators can confirm whether this screen is approved for their vehicle by checking for the Access Seating Australia Pty Ltd ID plate which is located on the upper metal support bar/structure behind the front seats. The MBGTH5000 screen is approved for Toyota HiAce vehicles fitted with this ID plate. Taxi operators should note that, at this time, a screen has not been approved for older type Toyota Hiace Vans (ie. pre-2005).

### **The TransitShield Model TSAHDN-301**

Approved for Holden Commodores VZ & VE and also Statesman and Caprice variants. This approval is inclusive of vehicles fitted with dual front airbags and side airbags (fitted within the driver's seat) but excludes those vehicles fitted with side curtain style airbags (fitted above the driver's side window/s).

***Screens must be fitted in accordance with the manufacturer's instructions as well as complying with relevant Australian Design Rules (ADRs).***
