IMPORTANT INFORMATION FOR APPLICANTS

- A Temporary Omnibus Licence is only available for existing omnibus operators to cover over-bookings or vehicle breakdowns and accidents.
- The vehicle being used must fit the requirements of the category of licence the Omnibus licence holder has been issued.
- The vehicle must have the appropriate insurance class;
 - 8 or more seats: 3A insurance class for vehicles principally operating on routes the major portion of which is within the 40-kilometreradius of the GPO Perth or 3B for vehicles principally operating on routes the major portion of which is outside the 40-kilometreradius of the GPO Perth
 - Less than 8 seats: 3F

If the vehicle does not have the appropriate insurance class the application will be declined.
- The temporary licence will not be issued for more than 30 days

CONDITIONS OF A TEMPORARY LICENCE

- The licence invoice must be paid before the licence becomes valid.
- The temporary licence and receipt must be kept in the vehicle at all times.
- The vehicle must abide by the licence conditions of the vehicle it is replacing.
- The driver of the vehicle must be licensed appropriately for carrying passengers for hire & reward.
- The vehicle must not be used past the VALID TO date printed on the licence.

If it is found that any of these conditions have been breached, the operator will not be eligible to apply for future temporary licenses.
