I, Poonam Kapoor, Executive Director, Driver and Vehicle Services, delegate of the Chief Executive Officer of the Department of Transport and Major Infrastructure (DTMI) under the *Towing Services Act 2024* (the Act), pursuant to regulations 14(2) and 29(1) of the Towing Services Regulations 2025 (the Regulations):

- (a) approve the manner and form as set out in the table below, to require a person specified in column 2 to report a notifiable occurrence listed in column 3 in the manner and form provided in column 5; and
(b) approve the Notifiable Occurrence Report Form in Attachment 1 as the form to be used for the purposes of the Regulations.
