



Application to License an Overseas Vehicle

Section 22 Road Traffic (Vehicles) Act 2012

When blank, this form is classed as OFFICIAL, when completed, this form is classed as OFFICIAL SENSITIVE

- To be eligible for a free licence, the applicant must be a resident of the country which issued the current licence and must not be a permanent resident of any Australian State or Territory.
- Applicant must produce a *Carnet* or *Triptyque* or such other documentary evidence establishing that the owner has given a guarantee to the Department of Infrastructure and Regional Development, that the vehicle is to be subsequently taken out of Australia and evidence of the vehicle being currently licensed overseas.
- Vehicle must be inspected prior to the grant of a Western Australian vehicle licence.
- An overseas vehicle licence becomes invalid if the owner (who is not a permanent resident of Australia):
 - becomes a permanent resident of Australia; or
 - transfers the vehicle licence to a permanent resident of Australia.
- A third party licence will be issued only to the expiry date of the registration document, *Carnet* or *Triptyque*; whichever comes first to a maximum of 12 months.
