This instrument may be cited as JR-2026-208598.

Fee Waiver

Pursuant to regulation 111 of the *Jetties Regulations 1940*, I, Mark Briant, being an authorised fee officer, and acknowledging the impact of Cyclone Narelle on Exmouth Boat Harbour in March 2026, hereby, by this written instrument, waive - in respect of the vessels listed below - an amount equivalent to three months of applicable berthing dues, subject to the following conditions.

Conditions

1. The vessel must have been subject to a valid vessel accommodation agreement during the period 1 January 2026 to 30 June 2027.
2. For the purpose of giving effect to this waiver, the amount corresponding to the waived three-month berthing dues may, upon written request by the registered penholder, be:
 - (a) refunded to the registered penholder; or
 - (b) credited against the berthing dues for the next accommodation period, thereby waiving three months in full or reducing the annual berthing dues by an amount equivalent to three months.
