



Registration of a Foreign Pleasure Vessel

When blank, this form is classed as **OFFICIAL**, when filled out, this form is classed as **OFFICIAL-SENSITIVE**.

A foreign pleasure vessel is a registrable vessel which is **owned by a person who is not a permanent resident of Western Australia (WA)** and is temporarily within WA navigable waters. **It does not include a registered interstate pleasure vessel.** If the vessel remains in WA navigable waters for a period greater than 30 days the vessel must be registered with the Department of Transport and Major Infrastructure (DTMI) as a Foreign Pleasure Vessel.

What is required

To register a Foreign Pleasure Vessel the Department requires the applicant to:

- pay a recording fee and the appropriate registration fee in accordance with the online schedule transport.wa.gov.au/marine/recreational-boat-registration.asp for each three (3) month period or part thereof for the proposed vessel to be used in navigable waters; and
- provide proof of identity (POI) documents (see below for details).

Proof of Identity (POI)

When you submit this form you must provide POI documents to the Department's Boat Registrations Office before this form can be accepted.

Applicants must submit one full POI (no other proof required) documents, including:

- a current photographic driver's licence;
- a current passport.

Secondary POI

If no full POI document is available, applicants will require two (2) secondary forms of identification including:

- a current non-photographic driver's licence;
- a foreign passport or foreign document of identity that is current or has expired within the last two (2) years;
- a full birth certificate, or an extract of birth certificate (must be certified copy from issuing body);
- a current credit card/account card, passbook or account statement not more than twelve (12) months old;

Company POI

If the vessel is to be registered in a company name the following documents are also required:

- a Certificate of Incorporation of the company (or a certified copy).

This application form must be signed by a Director or Company Secretary, in addition POI for the nominated contact person is required.

Privacy Collection Notice

DTMI collects your personal information, including your name, address, driver's licence number and date of birth to verify your identity and assess your application to register a foreign pleasure vessel. The details you provide are used on an ongoing basis for administering your records.

DTMI may disclose your information to law enforcement agencies, interstate or overseas licensing authorities, courts or other entities as permitted by law, including for identity verification and law enforcement purposes. The *Navigable Waters Regulations 1958* require that foreign pleasure vessels are registered with DTMI within 30 days of entering navigable waters. If you do not provide the details on the form your application may not be able to be assessed and registration may be refused.

DTMI is committed to protecting your privacy.
