- an interstate car (C class) or motorcycle (R-E class) learner's permit/licence;
- a New Zealand Class 1 (car) or Class 6 (motorcycle) learner licence; or
- an IOT car (C class) or motorcycle (R-E class) learner's permit/licence.

If the information given by you in this application is incomplete or the Department of Transport is not able to verify the learner driver competency completed, your learner driver competencies will NOT be recognised and you will be required to undertake them again.

**It is an offence under the *Road Traffic (Administration) Act 2008* to obtain, or attempt to obtain, a driver's licence through a false statement, misrepresentation or other dishonest means. Maximum penalty is \$1,600.**

# IMPORTANT INFORMATION

## WHEN TO LODGE THIS APPLICATION AND SUPPORTING DOCUMENTS

This application must be submitted at the time you apply for a WA driver's licence. Evidence of completed learner driver competencies will NOT be recognised after a WA learner's permit is issued.

## COMPETENCIES THAT CAN BE RECOGNISED

The Department of Transport will only recognise those learner driver competencies completed in the past five (5) years for interstate applicants or 12 months for NZ and IOT applicants. If this period has lapsed since the learner driver competency was completed the competency will not be recognised and further testing in WA may be required.

## SUPPORTING DOCUMENTS

### Holders of a learner's permit issued in another Australian jurisdiction or the IOT

You will need to provide documentary evidence of any supervised driving hours undertaken to support your application, for example, an approved learner Log Book. Your supervising driver must also complete the declaration on this form.

If you have been recording supervised driving hours in an electronic Log Book the hours recorded will only be recognised in WA if the electronic Log Book is approved for use in your home jurisdiction. Furthermore, the information printed from the electronic Log Book must provide the following:

- Learner driver details, including name and learner's permit/licence number
- Details of each supervisor, including name and driver's licence number or driving instructor number.
- Each trip entry must be verified or signed by the supervisor; and
- Each trip details, including trip duration (start and finish time).

The Department of Transport will verify information relating to any completed learner driver competencies from the Australian or IOT licensing authority where the competencies were completed.

### Holders of a learner licence issued in New Zealand

You must obtain a 'Certificate of Particulars' from the NZ Transport Agency and must request that it includes evidence of any learner driver competency completed and the date they were completed.
