



Private Property Towing Arrangement

Part 6A of the *Road Traffic Act 1974* requires a towing arrangement between an owner/occupier of private premises and a towing service provider that provides evidence of the owner/occupier requesting or permitting the towing of 1 or more motor vehicles parked at the premises by the towing service provider or a tow truck driver authorised by the towing service provider. A copy of a signed towing arrangement must be shown to a vehicle owner/driver or other authorised person if requested to do so. The Department of Transport is not a party to this arrangement. Any disputes relating to a towing arrangement is a civil matter between the two private parties to the arrangement.
