In this instance, a change of name only has occurred and therefore, vehicle licence duty and transfer fee will not be payable.

If a joint owner or the nominated owner/licence holder is to be removed from the vehicle record, this form must be completed and signed by each owner in conjunction with a 'Notification of Change of Ownership' (MR9) form. Transfer fees and vehicle licence duty (at the current dutiable value) will be payable.

Your personal driver's licence information, photograph, and vehicle licence information may be used, or disclosed to a third party, where authorised under 'road law' (as defined in the *Road Traffic (Administration) Act 2008*), or Commonwealth law or in compliance with a Court Order issued within Australia. Your personal details may also be disclosed to other driver licensing authorities to assess your application or verify any information you have provided.

## NEW NOMINATED OWNER/JOINT OWNER DETAILS
