IMPORTANT INFORMATION

ELIGIBILITY CRITERIA

- Only heavy vehicles with a Gross Vehicle Mass over 4.5 tonnes (4500 kg) are eligible for a seasonal licence.
- Plant and machinery vehicles and caravans are not eligible.
- Vehicles must be used for genuine seasonal work.
- Federal Interstate Registration Scheme (FIRS) vehicles are not eligible.
- Vehicles approved for seasonal licensing are not eligible for any concession on vehicle licence fees.

SEASONAL WORK

Seasonal work is any work that, due to weather or economic factors, regularly goes into hiatus for one or more parts of the year.

GARAGING ADDRESS (BASE OF OPERATION)

In accordance with s.5(3)(d) of the *Road Traffic (Vehicles) Act 2012*, vehicles cannot be licensed in Western Australia if they are kept in another state. You may be required to provide documentary proof of this.

NOMINATED ANNUAL START DATE

These are the annual date(s) at which it is anticipated the vehicle will need to be licensed. A renewal notice will be sent to the licence holder approximately 6 weeks prior to an annual start date each year. Nominated annual start dates may be changed at any time.

SEASONAL LICENCE PERIODS

A seasonal licence period must last for a minimum of 3 months. This period may be extended by a minimum of 1 month to cater for the unexpected extension of a 'season' due to weather or other factors. You must request the extension by contacting Driver and Vehicle Services and paying the relevant fees for the extended period.

NON-LICENCE PERIOD

You may apply for more than one 'season' during any 12 month period provided there is a minimum 'non-licence' period of 2 calendar months between each seasonal licence period. Renewals made within 2 months of the expiry date of a previous seasonal licence period must be treated as a continuation of the previous period (i.e. the licence is to be backdated) but retrospective licence and motor injury insurance cover will not be provided.

EXPIRED SEASONAL LICENCE/RETENTION OF SEASONAL PLATES

Provided a seasonally licensed vehicle is renewed within 12 months of the last expiry date, there is no requirement to return the number plates or have the vehicle inspected upon renewal of the licence. If beyond 12 months, the number plates are to be returned and the vehicle must pass an inspection before re-licensing.

NUMBER OF MONTHS REQUIRED

Must be a minimum of 3 months. This field is only mandatory when the first seasonal period is paid for at the time of this application. If you intend to pay for the seasonal period at a later date, this field can be left blank.
