Payment will not be regarded as an admission of liability for any civil claim, action or proceeding, but constitutes a conviction for the purposes of the Road Traffic (Authorisation to Drive) Act 2008 section 35(4)(b) (v), and the Road Traffic (Vehicles) Act 2012 section 126(6) and 128(4).

Section 16 of the Road Traffic (Authorisation to Drive) Act 2008 may apply to you.

For a provisional licence driver, payment for Road Traffic Act 1974 section 54, 55, 62 and 64AA offences constitute a conviction, licence cancellation and three months disgualification from driving.

Demerit Points and Penalties for this offence.

Demerit Points IF APPLICABLE to this offence are recorded at the time one of the following occurs.

- When this Traffic Infringement Notice is paid or at the first payment instalment
- When the Fines Enforcement Registrar makes an order after you have failed to take any action required in respect of this Traffic Infringement Notice.
- When the matter has been heard by a court and a finding of guilt has been declared and penalty pronounced.

If you are the holder of a driver's licence or permit issued outside Western Australia, demerit points are still recorded against your name and accumulate in the same manner.
