It is alleged that you committed the offence of failing to transfer the licence for vehicle 2008 MAZDA RX8 COUPE within 28 days of having a transfer notice issued.

- (2) Motor dealers are exempt from paying vehicle licence duty if the vehicle is acquired for the sole purpose of reselling it to another person, or loaning the vehicle to a charitable organisations, a school for driver education, philanthropic or other prescribed reasons. To be exempt you must complete the declaration (Part A) on the reverse of this notice.

OR

(3) You may elect to have the matter dealt with by a court. To do this you are required to advise the Department of Transport of your intentions by completing the Electing Action by Court (Part B) on the reverse of this notice. You must return this notice before 08 January 2024.
