To register a new recreational boat the Department requires that the applicant must provide:

- the **pink Hull Identification Number (HIN) Certificate** (*photocopies will not be accepted*);
- proof of acquisition** - may include any of the following:
A bill of sale; a detailed receipt; a consignment note; an offer to purchase; any document that provides evidence of ownership or a statutory declaration; and
- proof of identity (POI) documents** (see back of form for details).

- Any Additional owners will need to comply with either of the above.
