TERMS AND CONDITIONS FOR USE OF AN EMERGENCY MOORING	
<p>The terms and conditions on which any temporary use of an Emergency Mooring will be granted are contained on this application. It is very important that you read these terms and conditions and retain them for your records. These terms and conditions as amended from time to time, will also be binding on you. We strongly recommend that you read these conditions.</p> <p>The Department of Transport (DoT) will <u>grant approval for temporary occupation</u> on an emergency mooring site <u>subject to availability and the following conditions:</u></p> <ol style="list-style-type: none"> Your vessel is both registered and appropriately insured and remains so while moored at the site You agree to notify DoT of any damage your vessel may cause to the mooring and repair that damage to DoT's satisfaction You are responsible for any damage and costs that may occur to other vessel while using the emergency mooring The approval for this emergency mooring usage is <u>NOT TRANSFERABLE</u> DoT will bear absolutely <u>NO RESPONSIBILITY for any damage or incident that may occur</u> whilst the vessel is moored at this site Use of this emergency mooring site will <u>expire with a time determined by DoT</u> and you agree that your vessel will be removed from this one or before this date There will be no extensions granted for the use of this site The registered vessel must be in seaworthy condition so that the vessel capable if undertaking a voyage at all times In the event that this vessel has not been removed from the emergency mooring within the time stipulated, DoT may remove the vessel and all associated costs will be the responsibility of the owner.
