ELIGIBILITY

The rebate is only available for the following types of vehicle:

- Light vehicles with a gross vehicle mass of 4.5 t or less which are passenger vehicles, sports utility vehicles, light commercial vehicles, and light trucks;
- fully powered by batteries or hydrogen fuel cells (hybrid vehicles with internal combustion engines are not covered);
- a dutiable value of \$70,000 or less, Division 5 of the *Duties Act 2008*;
- never previously registered or licensed (anywhere in the world); and
- granted a vehicle licence in WA on or after 10 May 2022.

The following vehicles are not eligible:

- Hybrid vehicles with internal combustion engines;
- Motor carriers, Mopeds and Motorcycles;
- Heavy vehicles; and
- Vehicles that are not 'road vehicles' as determined under the Commonwealth *Road Vehicle Standards Act 2018* (for example; Off Road vehicles, Tracked vehicles, Agricultural Machines, Quad Bikes and Golf Carts.) MINIMUM PROCESSING TIMES

It will take up to four weeks from receiving your initial application to be processed and for your rebate to be issued.

REBATE DETAILS

The scheme will pay \$3,500 to the first 10,000 eligible vehicles until June 2025.

DUTIABLE VALUE

The term "dutiable value" is defined by the *Duties Act 2008*.

The following interpretation is provided as a guide only.

CERTAIN NEW VEHICLES

For new vehicles of a class prescribed in the *Duties Regulations 2008* with a price fixed by the manufacturer, importer or principal distributor as the retail selling price in Western Australia of that make and model, the dutiable value will be:

- the price fixed; and
- for each optional feature in or of the vehicle - the additional amount fixed by the manufacturer, importer or principle distributor for the retail sale in Western Australia of the optional feature. The price of other features or accessories that are not optional as defined (including, but not limited to, window tinting, DVD player, sound system speakers, mag wheels, paint, fabric and rust protection and rear spoilers) should not be added.

WARNING: The *Duties Act 2008* requires the purchaser to make a declaration as to the purchase price and estimated dutiable value of a vehicle. Failure to comply with the requirement is an offence for which a maximum penalty of \$20,000 is payable.
