COMPLIANCE REPORTING: PORT GEOGRAPHE DEVELOPMENT COASTAL STRUCTURES

Department of Transport (DoT), on behalf of the Minister for Transport, provides the attached compliance reporting pursuant to Condition 3 of Ministerial Statement 990 (MS 990) for the 2023–2024 annual reporting period.

It is requested that publicly available documentation be limited to the Statement of Compliance and the associated Audit Table. DoT requests to restrict the publication of confidential documents referenced in the Audit Table and the additional supporting documents. The supporting documents referenced in the Audit Table can be made available to Department of Water and Environmental Regulation (DWER) on request.

Pursuant to Condition 7.6 of MS 990, DoT completed an annual review of the EMMP and determined no changes were required for this compliance reporting period.

Therefore, the EMMP Management Target and overcharging Condition 7.2 of MS 990 were both met during this reporting period (BMT 2024b).


