



# On-demand Transport Standard Proof of Identity Requirements

**These requirements do NOT relate to an application for the initial grant of a Western Australian driver's licence, learner's permit or Photo Card or other transactions relating to vehicle licensing in Western Australia.**

If you hold a current driver's licence issued by an Australian jurisdiction you may submit your New On-demand Transport Customer application form via email and you must adhere to the following requirements:

- Provide certified copies of the original documents; and
- Provide two Secondary Identification documents (one of which must contain your current residential address).

If you do **not** hold a current driver's licence issued by an Australian jurisdiction you can only submit your application form by post and provide original certified copies that meet the following requirements:

- Provide one Primary Identification document; and
- Provide two Secondary Identification documents (one of which must contain your current residential address); and
- One of the identity documents provided must contain your signature.

## Primary Identification

- Australian passport which has not expired for more than two years.
- Current overseas passport
- Birth certificate (not an extract)
- Current Document of Identity issued by the Department of Foreign Affairs and Trade (DFAT)
- Consular photo identity card issued by DFAT
- Australian citizenship or naturalisation document or immigration papers issued by the Department of Home Affairs (DHA)
- Australian Migration Status (AMS) card issued by DHA
- Evidence of Immigration Status (EIS) card issued by DHA
- Permanent Resident Evidence (PRE) card issued by DHA prior to 1 July 2017
- Residence Determination ImmiCard (RDI) issued by DHA prior to 1 July 2017
- Western Australian Proof of Age card (not an 18+ card).
- Western Australian Photographic Firearms licence card.
- Photo Card (NSW).
- Personal information card (TAS).
- Proof of Age card (VIC, ACT, SA and QLD)
- Evidence of age card (NT).
- Industry Authority Card (QLD)

## Secondary Identification

- Current credit card or ATM card from a financial institution
- Passbook or account statement from a financial institution not more than 12 months old.
- Medicare card
- State or Commonwealth Government employee photo identity card.
- Telephone, gas or electricity account not more than six months old.
- Water or local rates notice, or land valuation notice not more than two years old.
- Evidence of electoral enrolment not more than two years old.
- Armed Services discharge papers not more than 12 months old.
- Current photographic Australian Defence Force identification card.
- Current photographic Police identification card.
- Current Australian issued security guard/crowd control licence.
- Current residential tenancy agreement.
- Current vehicle licence
- Recreational Skippers Ticket.
- Marine Licence Indicator Card
- Current Working with Children Card
- Marine Security Identity Card
- Aviation Security Identification Card
- ATO Tax File Number Letter
- ATO Tax Notice of Assessment Letter.

**The name on your documents must be the same or you must provide evidence of change of name that clearly shows the link between your birth name and current name.**
