



# Pensioner Annual Free Trip Scheme

## Application to Claim Entitlement: North of 26th Parallel

Pensioners who live north of the 26th parallel are entitled to one return journey by air or coach, per year, to Perth or elsewhere in the South West Land Division (provided the fare is not greater than that to Perth). WA residents living below the 26th parallel, must contact [TransWA](http://TransWA) on 1300 662 205 for details on their free travel entitlements.

### Important information before you book your travel:

- attach a copy of the front and back of your Department of Human Services (DHS) Centrelink or Department of Veterans' Affairs (DVA) Concession card/s.
- forms must be submitted at least one month before the first travel date;
- travel dates cannot be more than three months apart; and
- travel will not be approved if the first travel date is more than three months in the future.
