This form must be used to confirm that consent has been provided by the new vehicle licence holder of any vehicle that is authorised as a Passenger Transport Vehicle (PTV). It is used to confirm that the vehicle owner gives consent for someone else to hold a PTV authorisation for their vehicle. Both the PTV authorisation holder and the vehicle owner have responsibilities under s.148 of the *Transport (Road Passenger Services) Act 2018* to ensure the vehicle is safe and meets the required standards.

## IMPORTANT: PTV authorisations are not transferable. This form does not transfer a PTV authorisation to a new vehicle owner.
