
Western Australian electric vehicle licensing data

September 2025 Quarter


Key insights

September 2025 quarter Western Australian electric vehicle trends




Quarterly EV growth continues at double-digit pace

- **New** light vehicle licences in the latest quarter (Q3 2025):
 - All light vehicles (including EVs): 42,056
 - Light EVs only: 4,481 (10.7% of new light vehicle licences)



- Cumulative light vehicle licences as of 30 September 2025:
 - All light vehicles (including EVs): 2,173,007
 - Light EVs only: 42,472 (2% of all light vehicle licences)



- Cumulative light EV licences as of:
 - 30 June (Q2 2025): 38,110 (+13.3%)
 - 30 September (Q3 2025): 42,472 (+11.5%)
- EV growth continued at a double-digit pace in Q3 2025, rising by 11.5%, though slightly slower than the 13.3 % growth recorded in Q2.



Key insights continued



Highest quarterly increase on record for new BEV licences

- BEVs remain dominant, comprising 81% of all licensed EVs in the State. The net increase of 3,568 BEVs this quarter marks the highest quarterly increase for BEVs since reporting began.
- PHEVs account for the balance of 19% (+794). This is the lowest number of PHEVs licensed in a
 quarter since June 2024 (+444), suggesting a tapering trend after several quarters of above trend
 growth.



EV adoption broadening into growth suburbs and regions

- Herdsman/Osborne Park (6017) recorded the largest increase in licensed EVs this quarter, with a 27.9% surge, primarily driven by its strong business fleet presence.
- Other high-growth areas for the quarter reflect a mix of family demographics, new housing estates, and infrastructure availability, including:
 - Balcatta/Stirling (6021) up 15.3%
 - Perth (6000) up 13.5%
 - Beckenham/Cannington/East Cannington/Kenwick/Queens Park/Wattle Grove/Wilson (6107) up 16.4%.
 - Aveley/Belhus/Brigadoon/Ellenbrook/The Vines/Upper Swan (6069) up 14.6%.
- Regional WA accounts for 10.7% of new EV licences for the quarter, led by the South West (173) and Peel (166).
- The Kimberley posted the highest percentage growth at 20.8%, though from a small base.



Figure 1a: Graph - Cumulative electric vehicle data December 2021 to September 2025




Figure 1b: Table - Cumulative electric vehicle data December 2021 to September 2025
