



# Lost/Stolen Number Plates Notification

**When blank, this form is classed as OFFICIAL, when completed, this form is classed as OFFICIAL SENSITIVE**

This form is to be completed by the vehicle licence holder. Where the vehicle licence holder is a company, a declaration is to be made by an authorised representative of the company.

In the event that one or both number plate/s have been lost or stolen **and you require new number plates**, this form must be presented (with any remaining number plate), at a Drivers and Vehicle Services (DVS) centre, regional Department of Transport (DoT) office or participating DVS agent, where replacement number plates can be issued.

In the event that one or both number plate/s have been lost or stolen and you **no longer require** your vehicle to be licensed, you can post this completed form (with any remaining plate) to *Transfers and Plates Section, Drivers and Vehicles, GPO Box R1290, Perth WA 6844*. If both plates are lost or stolen, and you wish to end the vehicle licence, you can email this completed form to [transfers.licensing@transport.wa.gov.au](mailto:transfers.licensing@transport.wa.gov.au)
